In order to apply for our credit terms, the credit application form below must be completed and sent to Spirit Credit Management. The application on the 2nd page below is to be completed on-line by computer utilizing Adobe Reader software. [Click here for free Adobe download.](#) When the application is completed, sign it electronically by left clicking your mouse in the signature box and then left click the submit box at the bottom of the form. The application will automatically be attached to an email to Spirit Credit Management.

In addition to the credit application, please include the following as attachments:

- Trade Credit References – List a minimum of three references. Include complete address, phone number, fax number, email address and account representative.
- Bank Reference – Include complete name, address, phone number, fax number, email address, account officer and account numbers.
- Tax exemption certificate
- Any other essential information

Ensuring that the entire application is complete will help us to provide you with prompt and accurate service. *Incomplete applications will not be considered as an application for credit terms from Spirit Credit Management.*

Depending upon the amount of credit requested you may be required to submit your past annual financial statements and the most recent quarterly financial statements (Balance Sheet, Income Statement & Statement of Cash Flows). The amount of credit limit considered is limited to the amount of financial information submitted. It is the strict policy of Spirit Credit Management to not distribute financial information outside of our office. The information will be used for the sole purpose of evaluating the financial viability of your company.
