# Wichita IBEW-Represented Employees Temporary Layoff Information

Due to the continued impacts to the airline industry due to the COVID-19 pandemic and resulting uncertainty surrounding the return to service of the 737 MAX, all Wichita hourly employees directly associated with production work and support functions for the 737 program will be placed on a unpaid temporary layoff/furlough that may last up to 60 calendar days effective Monday, June 15 through Friday, August 14.

### The below information is intended to help answer questions you may have:

### 1. Time and Pay

- Your paycheck for all hours worked through June14 will be distributed through your current delivery method (direct deposit, pay card or mailed to your home address).
- Timecards will be automatically populated. No action is required to record time for the temporary layoff period.

#### 2. Earned Time Off

- Employees will continue to accrue earned time off during the temporary layoff.
- You may not take earned time off in lieu of the 60 calendar day temporary layoff.

#### 3. Benefits

- The Company will maintain medical, dental, life, and short-term disability, longterm disability, and accidental death and disability benefits so long as allowed by the benefit Plan document at issue.
- During this period, the company will pay your portion of health insurance, including supplemental life insurance, AD&D, and LTD. The missed premium payments during the temporary layoff will be placed in arrears and collected over a period of time after you return to work.
- With respect to the 401(k) benefit, employees will continue to earn vesting service hours and will be credited as if those hours were worked for any days required to be absent as a result of the temporary layoff.

### 4. Employee Assistance Program (EAP)

This is an uncertain time and it can be difficult to know how to best cope with your own feelings, or those of your loved ones. The Employee Assistance Program benefits will continued to be provided during this time.

### 5. Change of Address and/or Contact Information

## 6. Unemployment

Subject to approval by the Kansas Department of Labor, you are eligible for unemployment benefits.

- The one-week waiting period has been waived.
- Prior to June 20, 2020 you must log on to the Kansas Department of Labor website (<u>www.GetKansasBenefits.gov</u>) to set up direct deposit or pay card.
- On June 21 or 22 (Please note: the state's "week" does not align with Spirit's pay week).

- When you file each weekly claim, you will be asked whether you looked for work that week. You should answer "Yes" until told otherwise by the Department of Labor.
- On June 28 or 29 file a weekly claim for the week of June 21-June 27.
- On July 5 or 6 file a weekly claim for the week of June 28-July 4.To avoid disruption in unemployment benefits, affected employees must note receipt of holiday pay for the July 4<sup>th</sup> holiday when filing the weekly unemployment claim for June 28–July 4.
